for implementing the 2015-2020 Programme for Sustainable Local Development and Decentralisation for the 2018-2020 period

I. INTRODUCTION

1. Foreword

The Action Plan for the 2015-2020 Programme for Sustainable Local Development and Decentralisation in the Republic of Macedonia¹ (hereinafter: The Programme) is a step towards further operationalisation of the Programme and of other national strategic documents relevant for promoting sustainable local development and decentralisation in the Republic of Macedonia. This step means developing the strategic benchmarks envisaged in the listed documents, within the context of the current situation in the Republic of Macedonia, as well as of the European and global trends for achieving the sustainable development goals.

The Plan is a comprehensive operational document containing an overview of the planned activities of the relevant state authorities and organisations involved in implementing the priorities and the objectives of the Programme and Republic of Macedonia's resolution to continue with the decentralisation process, as an instrument for promoting local/territorial development.

This second Action Plan for the implementation of the Programme covers the 2018-2020 period. The development part, the First Action Plan for the implementation of the Programme covered the 2015-2017 period

One of the basic challenges of this Action Plan is that it should not replace the plans of the individual sectors it covers, but it is a framework for:

- integrating the sustainable development in planning and managing development at a local level, as the basic cell for the development of a state.
- mobilising, joining and coordinating all factors at national and local levels on topics that could contribute for achieving the United Nations sustainable development goals.

2. Methodological framework

The Action Plan was drafted in compliance with the methodology that envisaged implementing a transparent and participatory process, by involving all relevant institutions and stakeholders, that are important for the development of the local self-government and the decentralisation of the Republic of Macedonia. For that purpose, a Working Group was established to develop the plan, consisting of members nominated by 14 Ministries and 14 other public institutions (secretariats, agencies, directorates, centres, etc.). The Woking Group also collaborated with representatives of the civil society, chambers of commerce, planning regions and local self-government units.

3. Scope and structure

The following was taken into consideration when establishing the scope of the Action Plan:

- the political decision of the Government of the Republic of Macedonia to continue with the process of decentralisation, by promoting the local/territorial development as an important component of the national policy for sustainable development;
- the European Union vision for the new developing role of local authorities;
- the need to improve the coherency of the sustainable development policies and institutions as one of the objectives of the new global 2030 Agenda for Sustainable Development adopted by the global leaders at the United Nations Summit in September 2015;
- the need to reinforce the autonomy and the accountability of local authorities, as key factors in the processes for sustainable local/territorial development.

In the process of conceptualising the structure of the Plan consideration was given to the relation of the Action Plan with:

- the main goal and priorities of the revised 2015-2020 Programme for Sustainable Local Development and Decentralisation in the Republic of Macedonia; and
- the goals of the global United Nations 2030 Agenda for Sustainable Development

4. Financing

The activities established in this Action Plan will be financed and co-financed from:
